MILL CITY PLANNING COMMISSION Meeting of October 14, 2022

Planning Commission members present: Chair Marge Henning, Jim Grimes, Dave Leach, Sandy Lyness, Caitlin Purdy and Debbie Schenck.

The meeting was called to order at 8:34 a.m. Chair Marge Henning led the pledge of allegiance.

APPROVAL OF MINUTES: Sandy Lyness moved, seconded by Chair Henning to approve the minutes of September 2, 2022. The motion carried, (6:0).

OLD BUSINESS: Mill City Development Code:

<u>Psilocybin Time, Place, Manner</u>: Mr. Kinney said that a public hearing to consider changes to the zoning code to add time, place, manner language for psilocybin is set for Monday, October 21, 2022 at 6:30 p.m. This is similar to cannabis rules that were adopted. If the ballot measure asking whether to ban psilocybin within the City of Mill City passes then this code will not be needed. However, it is necessary to put the language into place should the ban not pass.

<u>Article 3 – Design Standards</u>: Mr. Kinney briefly went through the draft design standards code asking the Planning Commission to review the language and be prepared to discuss more fully at an upcoming meeting. Sections of this Article include:

5. Presentations & Discussions

Peter Olsen, PE, Keller Associates, will attend the November 18, 2022 planning commission meeting to discuss the wastewater system.

a. Wastewater Facilities Plan – Project Updates

Keller Associates has signed a contract with Marion County to prepare a <u>Wastewater Facilities</u> <u>Plan</u> and design a new Gates/Mill City wastewater treatment facility.

The <u>Wastewater Facilities Plan</u> must be prepared and approved by DEQ prior to authorizing the County to proceed with design of the new wastewater treatment plant, collection system and disposal site for the treated effluent.

b. Wastewater Inflow & Infiltration Investigations

The City public works staff suspects there is some significant inflow of surface water (rain runoff) or infiltration of groundwater into the sewer collection pipes in the NE quadrant of the City in Marion County. Pump records for the 1st Avenue pump station show that flows of water into the pump station are significantly higher during major rain events.

In September 2022, Keller Associates did a smoke test of the sewer MH at NE 7th Ave & Hwy 22 in hopes that this would show a broken pipe or major leak into the sewer system. It did not.

November 7-11, 2022, the City will do a TV inspection of the sewer lines in the NE quadrant of the City that flow into the 1st Avenue pump station. Peter Olsen will provide a report on the test results.

City staff hopes the TV inspection finds several major leaks which can be repaired and will reduce the daily flow of water/sewage during winter rain events.

c. Wastewater Capacity Discussion

Keller Associates has concluded the City is at or near capacity at the existing wastewater facility. During a 7" rain event in January 2021, the flow of sewage into the Mill City wastewater treatment plant exceeded the design flow limits in the City's NPDES permit.

Good news is the water quality of the effluent discharge from the wastewater plant to the drainfield continues to meet water quality standards.

Stacie and I are reaching out to Keller and the City Attorney's office to determine what advice we need to provide to the Planning Commission and City Council, as part of the staff reports for each of the upcoming development applications. We will share information from those discussions.

d. Storm Drainage Master Plan Update

Keller Associates has started work on the Storm Drainage Master Plan for the City. The initial phase is gathering data on existing pipes in the ground. We have reached out to Marion County, Linn County and ODOT for their information. City staff is copying subdivision plans, asbuilt construction plans and other old construction maps to share with the Keller staff.

Peter will give a very brief update on the project.



8b. Planning Consultant Report

a. Grant Applications and Awards:

i. ODOT - Safe Routes to School Project – \$2.0 Million Grant Request

The City submitted a \$2.0 million grant request to ODOT to fund sidewalk and crosswalk improvements near the Santiam Canyon Schools in Mill City. Grant award decisions should be made in mid-November 2022.

ii. ODOT - Small Cities Allotment - \$250,00 Grant Request - SW Ivy & SW Hall Paving

The City submitted a grant request to ODOT in August requesting funds to repave SW Ivy and SW Hall Street. Grant award decisions should be made in November-December.

iii. OPRD – Mill City Falls Park (Phase 2) - \$492,000 Grant Award

The City has been notified by OPRD that is will be awarded a grant to fund Phase 2 of the Mill City Falls Park project, including pathways, landscaping and a river overlook.

b. Mill City Falls Park – Overlook and Pathway Restoration

- i. <u>Phase 1 Overlook & Pathway Installation</u>. Siegmund Excavating is proceeding with construction of the wall and overlook. The new overlook and pathway restoration will be completed by March 2023, with landscaping to be installed afterward.
- ii. <u>Phase 2 Lower Park Design (ORPD & FEMA funds)</u>: The City has entered into design contracts with Brian Bainnson, Landscape Architect, Quatrefoil, Inc. and City Engineer John Ashley & Keller Associates to design the lower park and river viewing areas. Design will take 6-7 months. Bidding and construction will occur in 2023 and early 2024.

e. Water Improvement Project (Phase 2)

The Phase 2 water improvement project will begin construction in December 2022 or January 2023. D & I Excavating (Silverton) was awarded the contract for the project. A pre-construction meeting will be held in November 2022. The project includes the following water main replacements:

- 1st Avenue (SW Cedar south to Kingwood Avenue)
- SE 4th Avenue (SE Fairview to Kingwood Avenue)
- SE Grove (1st Avenue to SE 4th Avenue)
- NE 7th (NE Alder St. to Hwy 22)
- SE 8th (Linn Boulevard to SW Spring St.)

f. Cedar Creek Bridge Replacement

Kevin Groom, PE, Linn County Roads Department, has completed the 30% design plans for the Cedar Creek bridge replacement. The plans include replacement of the bridge destroyed by the Beachie Creek wildfire (on the pedestrian trail east of SE 5th Avenue, north of the N. Santiam River). The bridge design includes a concrete deck and railings to match the RR bridge design.
